

Pricing

Based upon our current understanding of the Teays Valley Facility Master Plan, The Pickering / Trinity:NAC team suggests the fee be structured on an Hourly Fee Basis with a Not to Exceed Budget Range of \$125,000 – \$150,000.

This Budget is an estimate only and does not include additional sub-consultant services.

In addition to fees, we will invoice for reimbursable expenses such as, but not limited to reprographics and deliveries. All reimbursable expenses will be billed at actual cost plus 10% administrative fee.

Travel to Hurricane or Charleston is not a reimbursable expense. Travel to other facilities outside of the CAMC network, if desired, will be billed at IRS approved rates / actual cost plus 10% administrative fee.

We look forward to meeting with you to align our work scope, schedule, and fee with your needs. The Pickering / Trinity:NAC team will look for opportunities to reduce the proposed time frame once we have a better understanding of the full project scope.



CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT

THIS CONFIDENTIALITY AND NON-DISCLOSURE AGREEMENT, is made and entered into as of the <u>16th</u> day of <u>June</u>, 2022, by and between **CHARLESTON AREA MEDICAL CENTER, INC**., a West Virginia nonprofit corporation, ("CAMC") and <u>Pickering Associates</u> ("Company").

WITNESSETH

WHEREAS, CAMC and Company are interested in reviewing and evaluating each other's business and operations in connection with their consideration of a possible contract or business arrangement between the parties (the "Proposed Transaction"); and

WHEREAS, CAMC and Company each agree to provide the other with certain information concerning their respective businesses and operations in consideration of, conditioned upon, and in reliance upon, the following mutual agreements and obligations:

(1) <u>Evaluation Material.</u> Each party hereto has received from the other party, and may continue to receive, certain oral and written information concerning the other party hereto with respect to the Proposed Transaction, which information is non-public, confidential, and/or proprietary in nature (the "Evaluation Material"). Each party hereto, together with its shareholders, members, affiliates and subsidiaries (as applicable, such party is referred to herein as the "Providing Party") has and will continue

to make such information available to the other party hereto (as applicable, such party is referred to herein as the "Receiving Party") pursuant to the requests of the Receiving Party only on the terms and conditions set forth below. Each Receiving Party acknowledges the confidential or proprietary nature of the Evaluation Material provided by the Providing Party and agrees to use the Evaluation Material provided to it by the Providing Party solely for the purpose of evaluating the Proposed Transaction and will not use the Evaluation Material provided to it by the Providing Party in any way to the detriment of the Providing Party. Unless and until the Proposed Transaction has been completed pursuant to written definitive agreements (the "Definitive Agreements"), such information will be kept strictly confidential by the Receiving Party, except that the Receiving Party may disclose the Evaluation Material or portions thereof to those trustees, directors, officers, employees, attorneys, accountants, consultants, financial advisors and agents (collectively, "Representatives") of the Receiving Party who (i) need to know such information for the purpose of evaluating the Proposed Transaction, (ii) agree to use such information solely for that purpose and not to use such Evaluation Material in any manner that materially and adversely affects the business of the Providing Party, and (iii) agree to be bound by the terms of this Agreement.

(2) <u>Scope of Evaluation Materials.</u> The term "Evaluation Materials", with respect to information provided, or to be provided, by the Providing Party, shall not include any information which, at the time of disclosure, is (i) generally available to and known by the public (other than as a result of its unauthorized disclosure by the Receiving Party or the Receiving Party's Representatives); (ii) available to the Receiving on a non-confidential basis prior to disclosure; or (iii) received by the Receiving Party concerning the Providing Party on a non-confidential basis from a third person who is not under an obligation to maintain the confidentiality thereof.

(3) <u>Cooperation with Disclosure.</u> If the Receiving Party or its Representatives are requested or required as a result of a judicial or regulatory proceeding (by oral questions, interrogatories, requests for information or documents, subpoena, civil investigative demand or similar process) to disclose any

Evaluation Material provided by the Providing Party, the Receiving Party shall provide the Providing Party with prompt written notice thereof so that the Providing Party may seek an appropriate protective order. The Receiving Party will cooperate with the Providing Party's efforts with respect thereto. If, in the absence of a protective order, the Receiving Party or its Representatives are, in the written opinion of counsel, compelled as a matter of law to disclose any portion of the Evaluation Material provided by the Providing Party, the Receiving Party may disclose to the person or entity compelling disclosure only the portion of the Evaluation Material that is required by law to be disclosed (in which case, prior to such disclosure, the Providing Party will be advised and consulted as to such disclosure and the nature and wording of such disclosure) and each party will use its reasonable best efforts to obtain confidential treatment thereof.

(4) <u>Time Limitation on Use of Evaluation Materials.</u> If Definitive Agreements are not signed within one (1) year from the date of this Agreement (subject to extension by mutual written agreement of the parties), each Receiving Party will promptly (i) return to the Providing Party all copies of the Evaluation Material provided by the Providing Party in the possession of the Receiving Party or its Representatives, (ii) destroy all copies of any analyses, compilations, studies, abstracts or other information prepared by or for the Receiving Party's internal use which reflects the Evaluation Material provided by the Providing Party's internal use which reflects the Evaluation Material provided by the Providing Party, whether in written or electronic format, and (iii) certify in writing to the Providing Party that all such documents, materials, and information have been so returned or destroyed, as the case may be.

(5) <u>Return of Materials</u>. Upon the Providing Party's request all documents and other tangible objects containing or representing the Providing Party's Evaluation Material and all copies (in whole or in part) thereof which are in the possession or control of the Receiving Party shall be promptly returned to the Providing Party or destroyed.

(6) <u>Confidentiality of Discussions.</u> Except as required by law, without the prior written consent of the other party, neither party will, and each party will direct its Representatives not to, disclose

to any person (i) the fact that Evaluation Material has been made available, or that a party has inspected any part of the Evaluation Material, or (ii) any of the terms, conditions, or other facts with respect to any such Proposed Transaction, including the status hereof.

(7) <u>No Warranties Regarding Evaluation Material.</u> Each Receiving Party hereto understands and acknowledges that neither the Providing Party nor any of its Representatives, and none of the respective trustees, directors, officers, employees, agents, members, stockholders, owners, or affiliates of the Providing Party or its Representatives, makes any representation or warranty, express or implied, as to the accuracy or completeness of the Evaluation Material provided by the Providing Party, and none of such persons will have any liability resulting from the use of the Evaluation Material by the Receiving Party or its Representatives, except with respect to any liability arising from a violation of the terms of this Agreement. Only those representations or warranties that are made in the Definitive Agreements when, as and if they are executed, and subject to such limitations and restrictions as may be specified in such Definitive Agreements, shall have any legal effect.

(8) <u>Trade Secrets.</u> Notwithstanding anything to the contrary in this Agreement, any trade secrets of a Providing Party also will be entitled to all of the protections and benefits under any applicable law. If any Evaluation Material which a Providing Party deems to be a trade secret is found by a court of competent jurisdiction not to be a trade secret for purposes of this Agreement, then such Evaluation Material will be considered confidential information subject to all of the protections of this Agreement. In the case of trade secrets, each party hereby waives any requirement that the other party submit proof of the economic value of any trade secret or posts a bond or other security.

(9) <u>No Obligations with Respect to Proposed Transaction.</u> Each party agrees that unless and until Definitive Agreements have been fully executed and delivered, neither will be under any legal obligation of any kind whatsoever with respect to such a transaction by virtue of this Agreement or any written or oral expression with respect to such a transaction by either party's trustees, directors, officers,

employees, agents or any other Representatives or the advisors or Representatives thereof except, in the case of this Agreement, for the matters specifically agreed to herein.

(10) <u>Remedies for Breach.</u> Each party specifically agrees that money damages would not be a sufficient remedy for any breach of this Agreement and the non-breaching party shall, therefore, be entitled to specific performance as a remedy for any such breach. Specific performance shall not be deemed to be the exclusive remedy for any breach of any provision of this Agreement but shall be in addition to all other remedies provided by law or equity. In the event either party initiates legal proceedings to protect its rights under this Agreement, the prevailing party in such proceeding will be entitled to payment of all reasonable costs and expenses, including without limitation, reasonable legal fees and disbursements, incurred by it in such proceedings as a court of competent jurisdiction may adjudge. No failure or delay in exercising any right hereunder will operate as a waiver thereof, nor will any single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right.

(11) <u>Miscellaneous.</u> Neither party may assign its interest in or delegate the performance of its obligations under this Agreement to any other person without obtaining the prior written consent of the other party. Should any part of this Agreement be invalid or unenforceable, such invalidity or unenforceability shall not affect the validity and enforceability of the remaining portions. Each individual signing this Agreement warrants that execution has been duly authorized by the party for which he or she is signing. The execution and performance of this Agreement by each party has been duly authorized by all applicable laws and regulations and all necessary corporate action, and this Agreement constitutes the legal, valid, and binding agreement and obligation of each party enforceable against each party in accordance with its terms. The waiver by either party of a breach or violation of any provision of this Agreement shall not operate as, or be construed to be, a waiver of any subsequent breach of the same or other provision hereof. No failure of a party to detect, protect, or remedy a breach shall be deemed a waiver of the party's rights. This Agreement constitutes the entire agreement of the parties hereto and

supersedes all prior agreements and representations with regard to the subject matter hereof. This Agreement shall be interpreted and construed in accordance with the law of the State of West Virginia.


